Attorney Jarrett not only is a member of NAELA, but is a founding member of the Vermont chapter of NAELA. He has regularly presented well-attended seminars on Elder Law to attorneys and financial professionals and has been interviewed numerous times on radio and television programs, including several “Across the Fence” programs produced by the Vermont Extension Service and broadcast on WCAX-TV.
